## **>>> EMPLOYER STATEMENT**

Our 6-month study of Regenexx cases that were all surgically bound, have been remarkable. All 8 cases referred to Regenexx have avoided surgery, recovered extremely well, and returned to work within 7 days or less. The other tangible cost is the savings we are achieving in our productivity. Typically, these cases would be out of work for 6-8 weeks, and at lost production time of \$82.00 per hour, per employee, the lost productivity is huge. This has been a win-win for the Employee as well as to our self-insured medical program.

### >>> **DISCLOSURE**

Conversion to Total Knee Arthroplasty (TKA): In our knee OA RCT, 12% of patients decided to get TKA despite treatment at 2 years. An analysis of our patient registry (100 patients, 100 charts reviewed, and 100% response rate) 14.8% of patients converted to TKA at 1-2 years when patients were TKA candidates.

Failure rates from Rotator Cuff Tear at 2-years were 10% which are similar to the registry data. The failure rate of Rotator Cuff repair for full thickness tears is higher, quoted as approximately 20%. We assumed that patients treated with Perc-RC Repair who were unhappy with their results would convert to a surgical repair at a rate of 10%.
